1. DEFINITIONS

In this Deed unless the context otherwise requires:







- "Trust Purposes" shall mean the objects set out under Clauses 5 of this Deed.

- "Trust" shall mean "DE PAUL ACADEMY TRUST".

2. ESTABLISHMENT OF AN EDUCATIONAL & CHARITABLE TRUST

- An irrevocable Charitable and Educational Trust which shall be known as "DE PAUL ACADEMY TRUST" is hereby established for the OBJECTS set out in clause 5 hereof. Its office shall be at De Paul Academy Trust, G. G. Patil Building, Near M. R. B. C. Main Gate, Ron, Gadag-582209, Karnataka; or at such place as the Trustees may decide from time to time and its activities shall extend throughout India, but no activity will be undertaken outside India.
- The benefits of the Trust shall be open to all irrespective of caste, creed religion or gender.
- The funds and the income of the Trust shall be solely utilized towards the achievements of the objects and no portion of it shall be



- k) To purchase, obtain on lease or in exchange or otherwise acquire any lands, buildings or other properties, both moveable and immovable, which may be necessary or required for all or any of the objects of the Trust and to sell, demise, lease, mortgage and give in exchange or surrender the same.
- l) To do all such other lawful acts and deeds as are essential or conducive to the Trust.
- m) The Trust established now under this Deed is IRREVOCABLE.

6. POWERS OF THE TRUSTEES

The Trustees shall have and may exercise all such powers, as in their opinion, enable them to effectively carry out all or any of the Trust purposes. Without prejudice to the generality of the foregoing, the Trustees shall have the following powers:

- To purchase, hire, take on lease or invest the Corpus of the Trust Fund or any part thereof, in lands and movable and immovable properties, including buildings, subject to clause 6 (g) below;
- To accept gifts in kind or in cash;
- To borrow moneys on such terms and conditions and (where applicable) subject to payment of interest or otherwise as the Trustees may consider necessary or desirable;
- To sell, mortgage, charge, lease, hire, invest or transpose the Trust investments;
- To open bank accounts and generally deal with the Trust Fund, or any part thereof as the Trustees may consider necessary or desirable;
- To raise additional funds for augmenting the Corpus of the Trust Fund, if necessary through appropriate programmes, to support the Trust Objects;
- To accumulate the income of the Trust for eventual application of the Trust Objects pending which to invest the accumulation strictly in accordance with the relevant provisions of the income tax Act, 1961, and particularly in accordance with S. 13(1) (d) read with section 11(5) of the said Act;
- To make donations or contributions to other Trusts, Societies and or Institutions as the Trustees may deem fit;
- To employ persons to assist the Trustees in carrying out the Trust purposes and to fix their remuneration and perquisites.

The funds of the Trust shall be invested in the modes specified under the provisions of Section 13(1) (d) read with section 11 (5) of the Indian Income Tax Act, 1961 as amended from time to time.

8. MEETING OF THE TRUSTEES

The Trustees shall hold meeting at such intervals as they may decide, but not less than once in every calendar year. The quorum at each such meeting shall be one half of the number of trustees or Two which ever is higher. Decisions at meetings shall be taken by majority vote unless otherwise provided herein. The Managing Trustee shall usually preside at the meeting of the Trust. In his absence any one of the Trustees present according to the opinion of the Board of Trustees can be the president.

9. POWERS AND DUTIES OF the managing TRUSTEE

The Managing Trustee shall attend to the day to day affairs of the Trust and shall exercise such powers and perform such duties as the Trustees may vest in him from time to time.

10. DECISIONS BY CIRCULATION

The Trustees may also take decisions by circulation of Trust matters approved by a majority of Trustees after the matters to be so decided have been circulated to all the Trustees, then in India.

11. REIMBURSEMENT OF EXPENSES AND REMUNERATION:

The Trustees shall be entitled to receive and be paid out of the Trust Fund, all out-of-pocket including traveling, conveyance and other expenses reasonably and legitimately incurred by them in connection with the Trust matters and

14. ACCOUNTS

For the proper conduct of the affairs of the Trust, the Trustees shall have the power to frame and implement Rules and Regulations which shall be consistent with these presents herein provided with the specific approval granted by the Settler of the Trust.

16. DISSOLUTION

If the Trustees shall be unanimously of the opinion that the Trust be dissolved such dissolution shall be affected by an instrument in writing under their hands and if, after all the debts and liabilities of the Trust have been paid or provided for, there shall remain any assets, the same shall be transferred to some other Trust, or Association having aims or objects which in the unanimous opinion of the Trustees are similar to all or any of the Trust Purposes. Or it shall vest with the Government.
